ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

of

THE CIRCLE OF PRAYER MININSTRIES OF FLORIDA, INC.

No part of the net earnings of The Circle of Prayer Ministries of Florida, Inc. shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other private persons, except that The Circle of Prayer Ministries of Florida, Inc., shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes.

No substantial part of the activities of The Circle of Prayer Ministries of Florida, Inc, shall be the carrying on of propaganda or otherwise attempting to influence legislation, and The Circle of Prayer Ministries of Florida, Inc. shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, The Circle of Prayer Ministries of Florida, Inc. shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).

Upon dissolution of The Circle of Prayer Ministries of Florida, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State or Local Government for a public purpose.
