

ARTICLES OF INCORPORATION

OF

ALL-STAR JAGUAR CHEERLEADERS, INC.

The undersigned subscriber to these Articles of Incorporation, hereby come to form a corporation not for profit under the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of such corporation.

ARTICLE I - NAME

The name of the Corporation shall be: ALL-STAR JAGUAR CHEERLEADERS, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business shall be Royal Palm Beach, Florida.

ARTICLE III - DURATION

The date when the Corporation's existence shall begin shall be the date of subscription and acknowledgment stated herein if this Certificate or Articles of Incorporation is filed within five (5) days, exclusive of legal holidays, after subscription and acknowledgment hereof, and are subsequently approved by the Secretary of State, and all filing fees and taxes paid; otherwise, it shall be the date when the Articles of Incorporation are filed in the office of the Secretary of State and approved. The Corporation shall have perpetual existence.

ARTICLE IV - PURPOSE

This Corporation is organized and shall be so authorized in conducting groups of cheer-leaders and all legally permitted activities associated therewith, permitted under the laws of the United States and the State of Florida.

Notwithstanding any other provision, the purposes for which the corporation is organized are exclusively charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

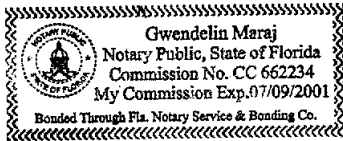

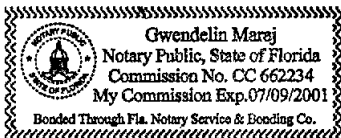
