

Dear Mr. Scott, Jr.:

I have been retained as counsel by the Board of Trustees of The Maitland Apostolic Church of Jesus, Inc. to advise and offer legal assistance in the enforcement and governance of the corporate authority at the Maitland Apostolic Church of Jesus, Inc. in Maitland, Florida.

This letter is specifically directed to you regarding your conduct and actions purportedly in assuming authority and exercising control over the financial and administrative affairs of the Maitland Apostolic Church of Jesus Orlando congregation.

### BACKGROUND

The Maitland Apostolic Church of Jesus, Inc (hereinafter "MACJ"), is a private, nonprofit corporation, governed by a sitting Board of Trustees. All actions to govern the affairs of the MACJ and its members are only authorized when taken by the MACJ Board of Trustees.

Bishop Cleveland Clark was among the initial founders of MACJ, and was duly appointed as the founding Pastor in 1963, and served until June, 2020. For all of the years during which Bishop Clark served as minister, he further served on the Board of Trustees, and as President of the Board. Throughout the history of his tenure on the Board of Trustees, Bishop Clark fully and completely recognized and, adhered to the authority of the Board of Trustees and the corporate governing body of the MACJ. In fact, he was the legal registered agent of the corporation. Bishop Clark followed legal and spiritual protocol to submit actions for the governance of the MACJ and its members to the Board of Trustees for official action.

For much of his tenure, Bishop Clark served as Senior Pastor of MACJ, and was recognized as an "Overseer." There is no official office of "Overseer" in the governance of MACJ. It has been an unofficial designation of respect and spiritual loyalty which was associated with Bishop Clark in view of his history and stature with the MACJ. Again, the Board of Trustees is the governing body of the MACJ, and Bishop Clark has been the executive and spiritual leader of the MACJ since its inception, under the authority of the Board of Trustees.

Bishop Clark became gravely ill in 2019, at which time he was ninety (90) years old. He gave a valiant effort to maintain his duties as the executive and spiritual leader of the MACJ. It became increasingly obvious that his physical health was severely restricting his capacity to do so. In or about June, 2020, members of the Board of Trustees approached Bishop Clark to discuss his retirement. As a result of these discussions, a full church meeting of the MACJ congregation was held in which the full church sat as a committee of the whole to consider the tenure of Bishop Clark as the Senior Pastor. In this meeting, a consensus decision was reached, including the consent of Bishop Clark, that he would resign immediately. At this same meeting Edwin Whitaker, Jr, an ordained elder of the MACJ, and member of MACJ for more than twenty-four (24) years, was appointed as interim Senior Pastor. Effective November 8, 2021, Mr. Whitaker, Jr.'s appointment is affirmed by the MACJ Board of Trustees.

### ILLEGAL CONDUCT

On or about October 8, 2021, you requested two individuals associated with the MACJ to meet you at a BB&T Bank in the local Maitland area. Under your direction and insistence Guanzella Scott, who was the Recording Secretary of the Board, and Financial Secretary of the MACJ congregation, and additionally Charles Reed, the Treasurer for the MACJ Board of Trustees, met you at a BB&T Bank. Under your direction and insistence a deposit account for MACJ was opened at BB&T. At this meeting, under your direction and insistence, Mr. Reed issued a check drawn on the MACJ official Wells Fargo bank account in the amount of \$100 to open the BB&T account as a depository account of MACJ. On this BB&T account, you are listed as an official signatory, along with Ms. Scott and Mr. Reed.

On October 10, 2010, under your direction and insistence, Mr. Reed issued a check drawn on the MACJ official Wells Fargo account in the amount of \$7,647.28. This represented the full balance then in the MACJ official Wells Fargo Account. Upon reason and belief, this check was then deposited into the BB&T account.

The Board of Trustees of MACJ did not authorize or consent to any of the financial actions described above. They were taken with no notice to the MACJ Board of Trustees, and with no authority delegated from the Board. While Mr. Reed was the Treasurer of the Board of Trustees, he did not have any authority to act unilaterally without action by the Board. The

official position of my clients, the Board of Trustees of the MACJ, is that these funds were stolen.

In addition to these actions, you made a demand to gain access to a safe deposit box owned by the MACJ Board of Trustees at the Wells Fargo Bank, That request was refused. You did however acquire a key to the post office box owned by MACJ. You further attempted to take actions to affect the positions and status of various officers and officials of the MACJ congregation. Your conduct has occurred in full view, and in some cases in the presence of congregants in the MACJ, and has resulted in unfortunate estrangement within this congregation.

Please be informed that it is the position of the MACJ Board of Trustees that you did not have, and currently do not have any authority to exercise any governance, or ministerial duties with respect to the MACJ, or to engage in, or serve in an any leadership capacity. I have been informed that you maintain that Bishop Clark issued a letter purporting to grand you some manner of authority. If any such letter exists, it has no legal basis or authority regarding the governance of the MACJ, and is an illegal intrusion into the authority of the Board of Trustees of the MACJ.

You are hereby commanded to IMMEDIATELY CEASE AND DESIST any and all actions to exercise any authority, control or governance of the Maitland Apostolic Church of Jesus, Inc. nonprofit corporation, the MACJ congregation, or any MACJ assets or property, either by you directly or by associates of yours acting on your behalf. You are commanded to immediately return and submit to my office all funds removed from the MACJ Wells Fargo bank account. You are further commanded to IMMEDIATELY CEASE AND DESIST engaging in any activity, correspondence or communications to any individual or organization which implies or directly states that you exercise any authority, control or governance of the Maitland Apostolic Church of Jesus, Inc. nonprofit corporation, the MACJ congregation, or any MACJ assets or property of the congregation..

Failure to comply with the commands stated herein within fourteen (14) days of your receipt of this letter, or yny violation of the edicts will result in a civil legal action against you individually, to include an action for civil theft. If the action(s) in violation of this notice is/are by an associate, I will gather any and all evidence needed to support a sworn complaint for conspiracy against that associate.

Feel free to contact me at (850) 491-2710, to answer any questions you might have. I thank you for your attention to this matter. Please govern your self accordingly.
