The undersigned Incorporator, for the purposes of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following articles of Incorporation.

Article I

NAME

The name of the corporation shall be Grand Palms Women's Golf Association, Inc. which is hereafter referred to as the "Association".

Article II

PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation shall be:

Article III

PURPOSE

The purpose of this Association is to promote good fellowship and sportsmanship amongst its members and to encourage the active participation of its members in playing golf and in taking part in tournaments conducted in accordance with the US Golf Association. The "Association" will also represent Grand Palms in competitive golf events.

Article IV

ELECTION OF DIRECTORS

The Executive Board appoints a Nominating Committee in August each year. The Nominating Committee for voting by the general membership will then submit a slate of Directors. Voting is completed by October 1<sup>st</sup>. for preparation of the new Directors for the start of the "Association" year in November. Directors of the "Association" are

President, Vice-President, Treasurer, Secretary and Tournament Director (s). Directors can hold the same office for no more than two years.

## Article V

### DIRECTORS

Section I. Management by Directors - The business and affairs of the "Association" shall be managed by the Executive Board of Directors which shall consist of not less than five, but as many persons as the Executive Board shall determine. The majority of the Executive Board of Directors shall constitute a quorum for the transaction of business. The Bylaws shall provide meetings of the Directors including the annual meeting of the general membership.

## Article VII

### CORPORATE EXISTENCE

The corporation shall have perpetual existence.

## Article VIII

### INDEMNIFICATION

Every Director of the "Association" shall be indemnified by the "Association" against all expenses and liabilities, including counsel fees reasonably incurred by or imposed upon it in connection with any proceedings or any settlements thereof to which it may be party, or in which it may become involved by reason of being or having been a director at the time such expenses were incurred, except in such cases wherein the Director is adjudged guilty of the willful misfeasance or malfeasance in the performance of this duty; provided that in the event of a settlement, the indemnification herein shall apply only when the Directors approve such settlement and reimbursement as being in the best interest of the "Association". The foregoing right of the indemnification shall be in addition to, and not exclusive of, the rights to which such Directors may be entitled.

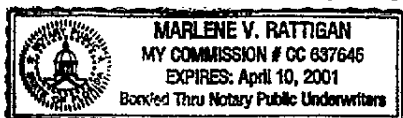
