#### <u>ARTICLES OF INCORPORATION</u> OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

#### Higher Education Achievement Society

#### A FLORIDA NONPROFIT CORPORATION

ARTICLE 1. NAME.	The name of the Corporation is the	HIGHER	EDUCATION	ACHIEVEMENT	SOCIETY	INC

ARTICLE 2. DURATION The duration of the Corporation is perpetual.

ARTICLE 3. PURPOSES. The purpose of the corporation is as follows:

- A) Higher Education Achievement Society is a not-for-profit corporation organized under chapter 617, Florida Statutes. It is not organized for the private gain of any person.
- B) The specific purposes of this corporation are charitable and educational. To help the community by giving underprivileged children a chance to attend college and enter the job market. Though this corporation local professionals can be mentors to College students in their field and College students mentor and tutor at risk Elementary and High School students. The organization assists students and parents with finding aid for college and or university education, help is also provided with filling out forms for federal aid and other types of aid over the internet. The organization also provides different mentoring and tutoring programs to public school students. The organization sponsors student internships while students are in junior and senior years of university.
- C) To exercise all rights and powers conferred by laws of the State of Florida upon nonprofit corporations.
- D) Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earning of the Corporation shall inure to benefit of or be distributed to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE 4 MEMBERS Higher Education Achievement Society shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the corporation. The bylaws provide for Nonvoting Members of three classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the bylaws, but who shall not have the right to vote.
