**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION

The following provisions of the Articles of Incorporation of **WCI COMMUNITIES/MERCEDES BENZ OF FORT MYERS JUNIOR GOLF FOUNDATION, INC.**, a Florida not-for-profit corporation ("Corporation"), filed in Tallahassee on October 13, 1999, under Document Number N99000006064, and amended April 18, 2001, hereby certifies as follows:

Pursuant to written action of the Directors of the Corporation, in lieu of a special meeting, the following resolution was adopted on June 28, 2010, amending the Articles of Incorporation. There are no members entitled to vote on the amendment.

RESOLVED, that Article I of the Articles of Incorporation, filed with the Secretary of State of Florida be amended as hereinafter set forth:

"Article I. Name

The name of the corporation ("Corporation") is WCI Communities Junior Golf Foundation, Inc."

WHEREUPON, at Bonita Springs, Florida, this 28th day of June, 2010, the Corporation hereby certifies accordingly, under its corporate seal and the hands of its President and Secretary, so that, on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
