## AMENDED ARTICLES OF INCORPORATION

*The undersigned, for the purpose of amending the corporation's Articles of Incorporation under the Florida Not for profit Corporation Act, hereby adopt(s) the following Amended Articles of Incorporation.*

### NAME

Myrtle Grove Neighborhood Watch, Inc.

### PRINCIPAL OFFICE

5398 Lillian Highway, Apt. # 35  
Pensacola, Florida 32506

### (Amended) ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

A. Educate the citizens of Myrtle Grove in crime/drug prevention through community educational meetings and the distribution of educational material about crime/drug prevention.

B. Provide a free citizens observation patrol to ride the streets of Myrtle Grove in marked "Neighborhood Watch" vehicles and report all suspicious activity of crime/drugs to the Escambia County Sheriff's Office by cellular phone as we observe it occurring.

We provide the services free of charge to the citizens of Myrtle Grove, we are staffed by volunteers who are not paid for their services. Our officers and board members are not paid for their services. We rely solely on donations and contributions from the citizens and businesses of Myrtle Grove.

All funds are kept in a business bank account, all checks written on the account require the signature of two board members as set forth in our bylaws.

C. In the event of desolution of the corporation all money and equipment will be turned over to another not for profit corporation, exempt under section 501(c) (3) and 170(c) (2) of the Internal Revenue Code of 1986 and all Chapter 617, Florida Statutes requirements.

*Article III was amended on November 16, 2000 at a scheduled business meeting, by a majority vote of the members and board of directors to meet the requirements for section 501(c) (3) and 170 (c)(2) of the Internal Revenue Code of 1986, as requested by the IRS.*
