ARTICLES OF INCORPORATION OF GRACE TABERNACLE OUTREACH AND FAMILY WORSHIP CENTER, INC.

We, the undersigned natural persons of the age 21 years or more, all who are citizens of the state of Florida, acting as incorporators of a corporation under the Florida Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation:

ARTICLE ONE

The name of the Corporation is Grace Tabernacle Outreach and Family Worship Center, Inc.

ARTICLE TWO

The Corporation is a Non-Profit Corporation.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

- 1. The purpose for which the Corporation is organized are: To provide a place of worship, to train and teach religious education, to ordain and license ministers, to maintain supply assistance in social and domestic needs, and all activities related thereto.
- 2. To purchase and own real estate and other property as may be necessary to carry out the object purpose of said, "Grace Tabernacle Outreach and Family Worship Center, Inc."
- 3. Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE FIVE

The street address of the initial registered/principal office of the Corporation is 533 Tall Top Drive Tallahassee, Florida 32310, and the name of its initial registered agent at such address is A. Reginald Thurman.

ARTICLE SIX

ARTICLE SEVEN

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE FOUR hereof. No substantial part of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing of literature or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision for these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from Federal income tax---section 501 (c) (3) of the Internal Revenue Code deductible under section 170(c) (2) of the Internal Revenue Code 1954 (or corresponding provisions of any future United States Internal Revenue Law).

ARTICLE EIGHT

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all assets of the Corporation exclusively for the purpose of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, religious, or scientific humanitarian purposes as shall qualify as an exempt organization or organizations of the future United States Internal Revenue Code of 1954 (or the corresponding provisions of the future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in the principal office of the corporation is located, exclusively for such purposes or such organization or organizations, as said Court shall determine, which are organized and operated for purposes.
