OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: **TALLAHASSEE JUNIORS VOLLEYBALL, INC.**

ARTICLE II DURATION

The duration of the corporation shall be perpetual.

ARTICLE III PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be: 4732 Pintail Drive, Tallahassee, Leon County, Florida 32311.

ARTICLE IV PURPOSES

The specific purposes for which the corporation is organized are: To promote and support the growth of youth volleyball in the Tallahassee/Leon County area; to provide opportunities for boys and girls, ages 11 through 18, to participate in organized volleyball activities designed to achieve the following goals: (1) learn sportsmanship and leadership skills, (2) learn the benefits

of setting individual and team goals in the context of volleyball, (3) provide opportunities for athletes to participate in the highest level of volleyball competition by traveling to USAV and AAU sanctioned tournaments, (4) provide opportunities for middle school students to prepare for high school volleyball competition, and (5) provide opportunities for high school students to prepare for college volleyball competition; to educate participants, coaches and parents in competitive volleyball; and to conduct or engage in all lawful activities within the scope of the organization in furtherance of the foregoing purposes, or incidental thereto.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

Directors of the corporation shall be elected in the manner stated in the Bylaws.

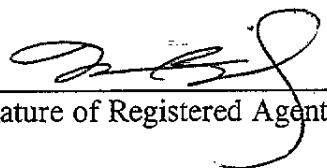
