## ARTICLES OF INCORPORATION

*The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.*

### ARTICLE I: Name

The name of this Corporation shall be:

### ARTICLE III: Purpose(s)

This Corporation shall be a non profit organization under §617, Florida Statutes. The purpose of the Corporation shall be charitable, scientific, religious, educational, and making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Service Code, or corresponding section of any future Federal Tax Code.
