**ARTICLES OF INCORPORATION FOR
MIDTOWN COMMUNITY ASSOCIATION, INC.**

The undersigned incorporator hereby incorporates this not-for profit corporation under Chapter 617 of the laws of the state of Florida, for the purposes contained herein.

I

NAME: The name of this corporation shall be the "MIDTOWN COMMUNITY ASSOCIATION, INC."

II

ADDRESSES: The street address of the initial principal office of the corporation and the mailing address for the corporation is 250 East Sixth Avenue, Tallahassee, Florida 32303.

III

PURPOSE: The corporation is organized for all purposes authorized under chapter 617, Florida Statutes (1999), including but not limited to the following purposes: to provide a support and networking group for businesses in the midtown area of Tallahassee, Florida; to offer practical advice and information to businesses in this area; to communicate with government officials on issues of significance to members of the association; to provide midtown businesses with an association to represent their interests in all forums, and to take all other lawful actions to represent the interests of members of the association.

IV

ELECTION OF DIRECTORS: The directors of the corporation shall be elected or appointed as set forth in the By-Laws.

V

LIMITATION ON CORPORATE POWERS: The corporation shall not be authorized to conduct any activity or take any action that will result in the corporation losing its status as a not-for-profit corporation under the laws of the state of Florida or any exemptions or special tax treatments under the laws of the United States of America, including but not limited to the United States Internal Revenue Code.

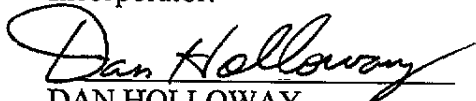
