THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation: Corporation Act" adopts the following articles of incorporation for such corporation.

ARTICLE ONE -- CORPORATE NAME

ARTICLE THREE -- PURPOSE OF BUSINESS

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act. 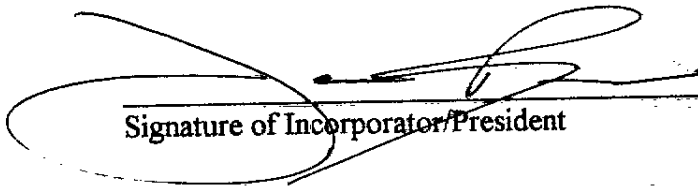
ARTICLE SIX -- AMENDMENT OF ARTICLE

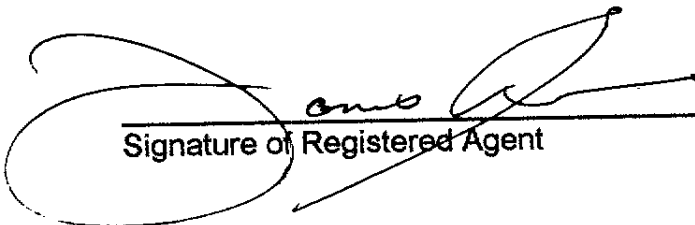
