
ONE: The name and address of this principal corporation is United Body Of Jesus Christ Inc., 1061 NE 153 Terrace Miami, Florida 33161, in Dade County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law, for charitable and educational purposes to take the city, promulgate the Gospel of Jesus Christ by media, tape, and signage to aid the poor and disadvantaged individuals and families towards a life of sufficiency. Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.

The purpose of the corporation shall be to cultivate, promulgate and extend the teaching of Jesus Christ. Not limited to establishing other facilities, bring God People together. Establishment of other ministries to see the ministries spread all over the world domestically and foreign. Be able to do all and any thing to carry out the works of God. with no limitations. In accordance with laws and not inconsistent with articles of corporation, and management of its affairs.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
