**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
SIDEWALK FUNDAY, INC.**

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of SIDEWALK FUNDAY, INC. (the "Corporation"), are hereby amended according to these Articles of Amendment:


FIRST: The name of the Corporation is SIDEWALK FUNDAY, INC..

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

"The name of the Corporation is SIDEWALK FUNDAY SCHOOL, INC.

THIRD: The foregoing Articles of Amendment (a) were adopted and approved by the Board of Directors of the Corporation on JANUARY 25, 2000 and (b) were adopted and approved by the affirmative vote of a majority of the members of the Corporation having voting rights, present at a meeting of the members on JANUARY 25, 2000, at which meeting a quorum of the voting members of the Corporation was present, and the number of votes cast in favor of the Articles of Amendment was sufficient for its approval, or (c) there are no members of the Corporation entitled to vote on the Articles of Amendment.
