# ARTICLES OF INCORPORATION FOR HIGHWAYS & HEDGES - SHINING LIGHT MINISTRIES, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

#### ARTICLE 1 Name

The name of this corporation is Highways & Hedges - Shining Light Ministries, TNC.

## ARTICLE 2 Principal place of business and mailing address

#### ARTICLE 3 Purposes

The purposes for which the corporation is organized are exclusively religious and charitable within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
