**ARTICLES OF INCORPORATION
FOR
HIGHWAYS & HEDGES - SHINING LIGHT MINISTRIES, INC.**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

**ARTICLE 1
Name**

The name of this corporation is Highways & Hedges - Shining Light Ministries, *INC.*

**ARTICLE 2
Principal place of business and mailing address**

The address of the principal office and the mailing address for Highways & Hedges - Shining Light Ministries, is 4133 Spring Creek Highway, P O Box 784, Crawfordville, FL 32326. *INC*

**ARTICLE 3
Purposes**

The purposes for which the corporation is organized are exclusively religious and charitable within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

The specific purposes of this corporation are to go out into the highways and hedges to distribute food and clothing, and to share the message of the hope and love we have through Jesus Christ.

**ARTICLE IV
