The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby voluntarily associate themselves for the purposes of forming a corporation not for profit under Chapter 617, Florida Statutes.

Article I: Name. The name of this corporation is YES I BELIEVE CLUB OF COLLIER COUNTY, INC.

ARTICLE II: Mailing Address. The address of the principal office of the corporation and the mailing address is 621 Ridge Drive, Naples, Florida 34108.

ARTICLE III: Duration. The term of existence of the corporation is perpetual, and the corporate existence will commence on the filing of these Articles by the Department of State.






ACCEPTANCE OF RESIDENT AGENT
