The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

Article I Name:

(or the corresponding provision of any future United States Internal Revenue Law)

Article IV Manner of Election of Directors

The manner in which the directors are elected or appointed is: The activities and affairs of the corporation shall be managed by a Board of Directors who will be appointed on an annual basis. The number of Directors and/or Officers shall not be less than three.
