1st AMENDMENT

CADL ARTICLES OF INCORPORATION

I, William S. Hollis, President, of the CADL, the Christian Anti-Defamation League, Inc., a State of Florida Non-Member, Non-Profit, Corporation - with the unanimous consent and approval of the Board of Trustees and Directors of CADL on February 6, 2006 - do hereby file for recording the following Amendment to the Articles of Incorporation of CADL originally filed on October 21, 1999:

Sub-paragraphs (1), (3), and (4), of the Third Paragraph of the original Articles of Incorporation are expunged and replaced with the following sub-paragraphs, as follows:

Par. 3(1): The Corporation is a publicly supported organization that is publicly organized and operated exclusively as and for public/charitable and educational purposes, and not for any private individuals and/or institutional interests, but instead, for the common interests of the general public including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Sec. 501(c)(3) of the U.S. Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation's products will be for the benefit of, and available to, all members of the general public at either no cost except, in the case of printed publications, either no costs or nominal costs limited to no more than actual costs as determined by the good faith judgment of the Board of Trustees and Directors.

Par. 3(3): The purposes it will pursue are to eliminate defamation of Christians; to advance proper understanding among all peoples; and to preserve and translate into greater effectiveness the principles of freedom, equality, and democracy.

Par. 3(4): The purposes of the Corporation shall be to advance the cause of civil liberties with particular emphasis on freedom of speech, press, association, and religion, and the other guarantees of the Bill of Rights; exercise of the franchise, due process of law, and equal protection of the law, and to take all appropriate action in the furtherance and defense of such purposes without political partisanship of any kind.
