# ARTICLES OF INCORPORATION

**OF** 

# NATURE COAST SENIOR SERVICES, INC. A Florida Corporation

PARTIE OF THE PA The undersigned, for the purpose of forming a corporation not for profit, pursuant to Chapter 617, Florida Statutes, as amended, does hereby certify as follows:

#### ARTICLE I

The name of the corporation shall be as follows:

NATURE COAST SENIOR SERVICES, INC.

#### ARTICLE II

The term of the existence of the corporation is perpetual commencing upon the filing of these Articles of Incorporation.

# ARTICLE III

The corporation is a nonprofit corporation under the laws of the State of Florida. The corporation is not formed for pecuniary profit. No part of the income or assets of the corporation is distributable to or for the benefit of its members, directors or officers except to the extent permissible under law.

## ARTICLE IV

The nature, objects and purposes for which the corporation is to exist shall be as follows:

- (a) To operate for the advancement of charity and education and for other charitable purposes, to wit, to serve the elderly citizens of Gilchrist, Levy, and Dixie Counties, Florida. The Corporation is committed to providing a range of services including delivering personal care, homemaking, transportation, nutritional meals, and educational services to senior citizens in the three counties.
- (b) The purposes for which the corporation is organized are sively charitable and educational within the meaning of exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations qualifying as tax-exempt organizations under that code. Notwithstanding any other and other purposes. organizations under that code. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- (c) No part of the net earnings of the corporation shall inure to the benefit of any member or manager of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes) and no member or manager of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations

described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

#### ARTICLE V

The corporation shall have a membership distinct from the Board of Directors. The qualifications for membership and the manner of their admission shall be regulated by the By-Laws.

#### ARTICLE VI

The incorporator of these Articles of Incorporation is as follows:

# ARTICLE VII

The business affairs of the corporation shall be managed by a Board of Directors. The Board of Directors shall be composed of not less than five (5) and no more than ten (10) persons. Membership on the Board of Directors shall be for such period of time as prescribed by the By-Laws of the corporation and said By-Laws shall prescribe the method by which the members of the Board of Directors shall be nominated and elected, and the qualification necessary for nomination and election to said Board of Directors

necessary for nomination and election to said Board of Directors.

The Board of Directors shall elect the following officers:

President, Vice President and Secretary/Treasurer, and such other officers as the By-Laws of the Corporation may authorize the Directors to elect from time to time. The principal address of the corporation shall be Post Office Box 1636, Chiefland, FL 32644.

#### ARTICLE VIII

The first Board of Directors shall consist of eight (8), who shall serve until the expiration of their term or until their respective successors are duly elected and qualify in accordance with the By-Laws of the corporation, subject, however, to earlier termination of the term of any such member or from time to time as may be prescribed by the By-Laws of the corporation. 
