ARTICLES OF INCORPORATION OF STATE OF FLORIDA SET FREE MINISTRIES, INCORPORATED

BE IT KNOWN, that on this 22 day of October, duly commissioned and qualified, in and for the Parish of Palm Beach County State of Florida, therein residing, and in the presence of the witnesses hereinafter named and undersigned:

PERSONALLY CAME AND APPEARED:

Barbara Dunnaway of West Palm Beach, Florida whose name is herewith subscribed, of full age, who declared that availing herself of the benefits and provisions of the Constitution of the State of Florida and the laws of said State relative to the organizations of a non-profit corporation, and particularly of the provisions of R.S. 12:1 et seq., she does by these presents form and organize herself, as well as all others who may hereafter join or become associated with her or her successors, into a non-profit corporation for the objects and purposes and under the covenants, stipulations and agreements following, to wit:

## ARTICLE I

# NAME

The name of the Corporation is Set Free Ministries, Incorporate

ARTICLE II

#### **PURPOSE**

The object and purpose for which this corporation is organized is to advance religious and general interests of the Parish of Palm Beach County.

#### ARTICLE III

## **STATUS**

The corporation is to be organized on a non-profit basis. There shall be one class of membership with all members having equal voting privileges.

The By-Laws may provide for the qualifications of members and the termination of membership by the Board of Directors. Membership of any individual may be terminated by a majority vote of the Board of Directors, with or without cause, if they feel it is in the best interest of the corporation.

# ARTICLE IV

#### **INCORPORATORS**

#### DIRECTORS

- A. Only members may be directors.
- B. Number of Directors: The number of directors of the corporation shall be such number, not less than three or greater than six, as shall be designated in the by-laws, or if not so designated, as shall be elected from time to time by the shareholders.

These Articles of Incorporation may be amended by a vote of eighty (80%) percent of the members at any regular meeting, or such special meeting called for that purpose, provided that such proposed amendments shall be plainly stated in the call for the meeting at which they are to be considered.

No member of this corporation shall ever be held liable or responsible of the contracts or faults of this corporation nor shall any mere informality in organization have the effect of rendering this charter null or of exposing members to any liability other then as above provided.
