Article of incorporation of the undersigned, desiring to form a non-profit missionary magazine corporation Law of chapter 617, Florida Statutes, do hereby certify:

ARTICLE 1. NAME

ARTICLE 4. PURPOSE (S)

ARTICLE 5. CORPORATION DISSOLUTION

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered. Otherwise attempting to influence legislation, and the Corporation shall not Participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any part of these articles. This Corporation shall not carry on any other activities not permitted to carry on. (a) By a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (b.) By a corporation, contributions to which are deductible under Section 170(C)(2) of the Internal Revenue Code, or the corresponding section of any future tax code. The Corporation Distribution of Assets, upon the dissolution or winding up of this corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation, shall be distributed equally among. Power From On High Ministries, Inc. and Anointed Christian Faith Center, Inc.
