ARTICLE IV. PURPOSE

The specific purposes for which this corporation is organized are as set forth below:

(a) To assist in the mental, physical, moral and emotional development of preschool children who are economically disadvantaged or exposed to substance abuse, alcohol, domestic violence, and juvenile delinquency.

(b) To provide after school care and activities for school age children who would otherwise lack supervision.

(c) To shelter, educate, and care for teenage girls who are pregnant.

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of section 501[c][3] of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal Income Tax Section 501 [c][3] on the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c)(3) of the Internal Revenue Code, of the Federal, State, or local government for exclusive public purpose.
