#### ARTICLE I - NAME

The name of this corporation shall be Florida Marine Youth Institute, Inc.

#### **ARTICLE II - PURPOSE**

The Corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)3.

#### **ARTICLE III - TERM OF EXISTENCE**

This corporation will exist perpetually.

#### **ARTICLE IV - PRINCIPAL OFFICE**

The address of the initial register office is 16019 Eagle River Way, Tampa, Florida 33624 and the name of the initial registered agent is Victor Young located at the initial address. The registered office may be moved from time to time by action of the Board of Directors.

#### ARTICLE V - BOARD OF DIRECTORS

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)3 of the Internal Revenue Code or (b) by a corporations contributions to which are deductible under section 170(c)2 of the Internal Revenue Code (or corresponding section of any future Federal tax act.

#### **ARTICLE IX - DEDICATION OF CORPORATION ASSETS**

Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for public purpose.


