SECRETAL AND SECONSTRUCTION OF AND SECONSTRU BY THESE ARTICLES OF INCORPORATION, the subscribers form a corporation under Florida law.

- 1. NAME, The name of the corporation is: IGLESIA EVANGELICA NUEVA VIDA, INC.
- 2. NATURE OF BUSINESS. The corporation shall engage in any non-profit activity permitted under the laws of the United States or this State or both.
