ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE CASCADES OF VERO PROPERTY OWNERS' ASSOCIATION, INC.

WHEREAS, it is in the best interest of the Corporation, THE CASCADES OF VERO PROPERTY OWNERS' ASSOCIATION, INC. ("Corporation"), to amend its Articles of Incorporation; and

WHEREAS, there are at present no members entitled to vote on a proposed amendment; and, as such, the Board of Directors by written resolution adopted the amendments set forth herein on December 1/1, 1999; and

WHEREAS, the text of the amendments is set forth below.

BE IT RESOLVED, therefore, that the Articles of Incorporation of the Corporation are hereby modified and amended, as follows:

1. Article II of the Articles of Incorporation shall include the following additional language:

The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. ______ requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

2. Article V of the Articles of Incorporation shall include the following additional language:

Existence of the Association shall commence with the filing of these Articles of Incorporation with the

Secretary of State, Tallahassee, Florida. The association shall exist in perpetuity.

3. Article VII of the Articles of Incorporation shall include the following additional language:

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

4. EXHIBIT "A" attached hereto is hereby deemed incorporated into and included in the Articles of Incorporation, as if and to the same extent as if the said EXHIBIT "A" had been attached to the Articles of Incorporation when filed on October 25, 1999.
