## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE CASCADES OF VERO PROPERTY OWNERS' ASSOCIATION, INC.

THESE ARTICLES OF AMENDMENT are entered into on the dates set forth below:

#### WITNESSETH:

WHEREAS, the Articles of Incorporation of the Corporation were filed on October 25, 1999; and
