A FLORIDA NOT-FOR-PROFIT CORPORATION

ARTICLE I

NAME

The name of this corporation is: EXPLORERS BOOSTER CLUB, INC.

ARTICLE II

ENABLING LAW

This Corporation is organized pursuant to the corporation's not-for-profit law of the State of Florida, set forth in Part 1 of Chapter 617 of the Florida Statutes.

ARTICLE III

PURPOSES

The purposes of this Corporation are as follows:

1. The specific and primary purpose for which this Corporation is organized is to acquire, maintain, construct, improve, provide and furnish real property and/or personal property and/or cash as a fundraising group for the students enrolled in the gifted program at Florida City Elementary School, as described in Section 501(c)(3) of the Internal Revenue Code of 1986 as amended (hereinafter the "Code").

2. This Corporation shall have the power to receive gifts of real property and/or personal property and/or cash to accomplish the above listed purpose.

3. The Corporation shall operate exclusively in a manner which is consistent with Section 501(c)(3) of the Internal Revenue Code.
