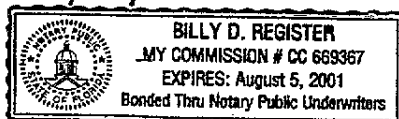

Article IV

The qualifications for members and the manner of their admission are:

Inasmuch as the purpose and objectives of the corporation are carried out by a team effort, all persons permanently enlisted to help to carry out the purpose and objectives of the corporation shall be considered members of the team.
