Article IV

The qualifications for members and the manner of their admission are:

Inasmuch as the purpose and objectives of the corporation are carried out by a team effort, all persons permanently enlisted to help to carry out the purpose and objectives of the corporation shall be considered members of the team. Persons so enlisted must be approved by a majority vote of the Board of Trustees and must have the ability to enhance the legal effort by defending, teaching or some other necessary functions. Persons so enlisted may make suggestions and offer advice to the corporation, but the board of trustees shall be the ultimate authority of the corporation. Members shall not be solicited from the general public.
