Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**ARTICLE I**  
**NAME**

The name of the Corporation shall be: **CHILDREN WITH A REASON TO LIVE FOUNDATION, INC.**

**ARTICLE II**  
**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III**  
**PURPOSE(S)**
