ARTICLE OF INCORPORATION
of
Rev. 22: 13 " the Alpha & Omega" A - Z Youth Center, INC.

We, the undersigned officers of Rev. 22:13 "the Alpha & Omega" A - Z Youth Center in accordance with the charter and the by-laws of said corporation, incorporate under the laws of the State of Florida, do submit the following proposed charter for incorporation of this corporation:

ARTICLE I.

The name of this corporation shall be: Rev. 22:13 " the Alpha & Omega A - Z Youth Center, Inc.

ARTICLE II.

A. The general purposes and objects of this corporation shall be to conduct " welfare " to its community to help the needy youth. On A - Z level & aspect "HELP--Service" such as A) academically (afterschool programs for its grade school students, full scholarship for its college level students) B) socially (outing weekly, historical field trips) C) morally / & civic/civilly (Prevention- -workshop regarding peer pressure, criminal laws; visit jails and prisons & Rehabilitation Programs) D) Physically (feeding, clothing, providing medical care, sheltering them as the need arise ; furthermore, proclaiming the Good News--Jesus to them and the rest of the world by serving their needs as Jesus did when He was among us "Emmanuel-- in Flesh & Blood " .

B. All revenue, profit, income, money received, donation from the conduct of such business or enterprise is to be used in employed for the needy and not for the benefit of the members of said corporation

ARTICLE III.

A. Any Youth (5 - 25 years old) who publicly demonstrate/assess any need academilly, socially, morally/civic/civilly, physically (for food, shelter, clothes, education, lawyers, medical care etc.) is a qualified an eligible recipient of the service of this corporation.

ARTICLE IV.

This corporation shall have perpetual existence.

ARTICLE IX.

A. This corporation may adopt such By-Laws as it may deem necessary in the manner hereinafter provided, for the transaction of its business, insofar as said By-Laws are not in conflict with provisions of this Charter.

B. One night in each month shall be set apart for the transaction of the business of said corporation, and shall have the power to make such By-Laws as they deem advisable as hereinafter provided.

C. The By-Laws of the corporation may be amended by a majority of those present at any regular business meeting provided notice of intent to amend has been included in the business bulletin and announced at regular business services on the Sunday prior to said meeting.

ARTICLE X.

Amendments to the Chapter of the corporation may be made by a two-thirds majority of those present at any regular business meeting provided notice of intent to amend has been included in the business bulletin and announced at regular business services on the Sunday prior to said meeting.

ARTICLE XI.

A. Said corporation is to have the powers to do any and all things necessary or expedient for carrying out the said objects and purposes of the said corporation and in general to possess all right, privilege and immunities, and enjoy all the benefits granted to corporations of similar character under the laws of the State of Florida.

B. The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall be seventy-five percent (75%) of the fair market value of all real estate owned by the corporation.

C. The amount and value of real estate, together with the permanent improvements thereon which this corporation may hold or own at any time shall not exceed \$5,000,000.00 subject always to the approval of the Judge of the Circuit Court of Dade County, Florida.

ARTICLE XII.

The corporation shall adopt a seal which shall contain the words "Rev. 22:13 the Alpha & Omega A - Z Youth Center, Inc." and the words "Corporation not for profit". In witness whereof, we have hereunto set our hands and seals as incorporators this 15th day of September A.D. 1999.
