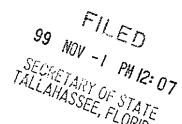

Articles of Incorporation For Jacksonville Masterworks Chorale



Articles of Incorporation of the undersigned as representatives of a body of individuals who desire to form a Non-Profit Corporation pursuant to Chapter 617, Florida Statutes, do hereby certify:

Article I - Name

The name of the corporation shall be:

The Jacksonville Masterworks Chorale, Inc.

Article II - Principal Place of Business

The place in this state where the principal office of the corporation is to be located in the City of Jacksonville, Duval County. 12987 Brady Road Jacksonville, FL 32223

Article III - Purpose

Said corporation is organized for educational purposes including:

- 1. The presentation of concerts of great choral music.
- 2. The rehearsal and training of singers in the choral art.
- 3. The preservation of civilization's finest choral expressions.
- 4. The establishment of a joyful fellowship for those who love the choral art.
- 5. The promotion of greater appreciation of choral masterworks among Northeast Floridians.

Article V Distribution of Earnings

No part of the earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VI - Dissolution of the Corporation

Upon dissolution of the corporation, the Board of Directors shall, as is consistent with existing laws of the State of Florida and section 501(c)(3) of the Internal Revenue Code, after paying all bills and meeting all obligations of the corporation, distribute the remaining assets of the corporation for one or more exempt purposes.
