The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE(S)

ARTICLE IV MANNER OF ELECTION OF OFFICERS


The manner in which the officers are elected shall be by open floor nominations at the annual meeting held in May of each year.
