1. Judy called the meeting to order and Glen led in prayer. Best wishes were expressed regarding Yvonne and the delivery of her son on Tuesday.

- 2. The minutes of the March 8,2001 meeting which were accepted as written.
- 3. In the Administrator's Report, Barrie reported on CC/BVMC/EUMC counseling hours and fees, Spiritual Direction hours and fees, new clients/referrals, and the family life education calendar.

Dennis Yoder explained the differences between the two, also recommended the Endowment Fund & Advancement Committee, and shared the attached info from MMA Endowment Fund. Dennis will ask Susan Kennedy to attend the May meeting to answer questions. Motion: To rescind the previous decision of having a foundation and proceed with establishing an Endowment Fund and Advancement

Committee. (Naomi/Rick) Passed

It was duly noted that the donor of the Yahoo stock approves that monies being used for whatever purpose when the stock is liquidated.

Dennis discussed the possibility of hosting a golf tournament at The

Meadows which would include lunch, golf, and cart for 144 people at a cost of \$40; could charge \$85-\$90 and obtain matching funds, plus hold an auction during lunch.

Motion: To authorize Dennis to move ahead with the golf tournament on November 3, 2001. (Jan/Janet) Passed

- 7. Glen, Joel and Deb are considering various combinations of pre-marital classes and counseling packages for couples. Christine Collins has been given approval to develop an intensive marital therapy program with Andy Stoner.
- 8. The long-range goals list prioritized by the counselors was reviewed.
- 9. There were no reports from the Finance or Personnel Committees.
- 10. Naomi left a message for Dave Anderson at Faith Baptist Church to give her a call. Next month will be Judy's last meeting.
