

ARTICLES OF INCORPORATION

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

OF

RAMDI PRIVATE SCHOOL, INC.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Non for Profit Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be Ramdi Private School, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be P. O. Box 300732, Fern Park, Florida 32730.

ARTICLE III - PURPOSES

The specific purposes for which this corporation is organize are:

To provide the opportunity of vocational and Christian education to children from the ages of eight to 12 years old, who has abandoned school, that are juvenile offenders or that has incurred in criminal violation of the law.

To provide to the children the opportunity of becoming useful, honest and responsible future citizens by providing a bilingual environment that motivates and develops each individual child on its stronger mental and physical areas of abilities, including: academics, arts, music, sport and Christian education.

To receive children's referrals from government or private entities as well as donations and/or assistance to achieve the social objectives of this corporation.

To periodically evaluate the academic, behavioral and social development of each of the children's participants.

To provide to each qualified children an equal opportunity without considering, race, color, origin, religion or socioeconomic background.

To provide to each children's participant boarding, a balanced diet, clothing, personal items, medical and dental assistance under the supervision of a qualified tutor or guardian.

To receive private donations and government assistance and to have, in furtherance of its not-for-profit corporate purposes, all of the powers conferred upon corporations organized under the Florida not-for-profit Corporation Act, subject to any limitations thereof contained and these Articles of Incorporation or under the laws of the State of Florida.

ARTICLE VI - MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors of the corporation be elected shall be so stated in the By-Laws.

ARTICLE V - INITIAL BOARD OF DIRECTORS

ARTICLE VI - OTHER PROVISIONS




