

## ARTICLES OF INCORPORATION OF EBENEZER COMMUNITY CHURCH, INC.

We, the undersigned, desiring to form a non-profit religious corporation pursuant to Chapter 617 of the Florida Statutes; do hereby make, subscribe and acknowledge these Articles of Incorporation, as follows:

#### ARTICLE I

The name of the Corporation shall be EBENEZER COMMUNITY CHURCH, INC.
The address is c/o Thomas Esward Greer, Jr., 9771 SW 216th Terrace,
Miami, FL 33190.

ARTICLE II

The principal office of the corporation shall be in Miami-Dade County. The specific location shall be determined by the Board of Deacons.

#### **ARTICLE III**

The date when the existence of this corporation commences shall be November 2, 1999.

#### ARTICLE IV TERM OF EXISTENCE

The corporation is to exist perpetually.

### ARTICLE V NATURE OF BUSINESS

The purpose for which the corporation is formed is for religious purposes within the meaning of Section 501 ©(3) of the Internal Revenue Code. The corporation will promote and function through church and community-based ministries in order to promote the Gospel while effectively provide spiritual and moral enrichment and community leadership. The corporation shall be governed by a Senior Pastor, a Senior Deacon, two other Deacons, a Secretary, and a Treasurer. A church Business Manager, other staff, and consultants may be hired to manage the implementation of the directives set forth by the Senior Pastor and the Board of Deacons. #### **ARTICLE X**

These Articles of Incorporation and the By-Laws of the corporation may be amended at any time by not less than two-thirds of the entire church membership. Any church member of the corporation may propose such amendments to these Articles of Incorporation or the By-Laws of the corporation.

#### ARTICLE XI

Nothing herein shall authorize the corporation, directly or indirectly, to engage in or include among its purposes or activities any purpose or activity prohibited under Chapter 617 of the Florida Statutes or contrary to the provisions of Section 501 © (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

#### ARTICLE XII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying out of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE XIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of the Board of Deacons exclusively for such purposes, or to such organization or organizations as the Board shall determine which are organized and operated exclusively for such purposes.
