ARTICLES OF AMENDMENT  
By Unanimous Consent of the Trustees (Directors)

ARTICLES OF AMENDMENT PURSUANT TO  
SECTIONS 617.1001, 617.1002 & 617.1006 OF  
THE FLORIDA NOT FOR PROFIT CORPORATION ACT

Pursuant to the provisions of Sections 617.1001, 617.1002 & 617.1006 of the Florida Not For Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment:

(1) The name of the corporation is FELLOWSHIP FOR INTERNATIONAL REVIVAL AND EVANGELISM, INC. Document Number N99000006593.

(2) The text of the amendment adopted:

“ARTICLE VI - LIMITATION OF POWERS” on page 3 is changed to:  
“ARTICLE VII - LIMITATION OF POWERS” to reflect the correct numbering.

All of “ARTICLE VII - MEMBERS” including text on page 4 is deleted. It is a duplicate of “ARTICLE VI - MEMBERS” on page 3.

Three additional articles are added as follows:

**ARTICLE XV - LIMITATION OF LIABILITY OF TRUSTEES AND OFFICERS**

A trustee or officer is not liable to the Corporation or members for monetary damages for an act or omission in the trustee's or officer's capacity except to the extent otherwise provided by a statute of the State of Florida.”

**ARTICLE XVI - INDEMNIFICATION**

The Corporation may indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was an officer or other person related to the Corporation as provided by Section 617.0831 of the Florida Statutes. As provided in the bylaws, the members shall have the power to define the requirements and limitations for the Corporation to indemnify officers, members, or others related to the Corporation.


## ARTICLE XVII - CONSTRUCTION

All references in these Articles of Incorporation to statutes, regulations, or other sources of legal authority shall refer to the authorities cited, or their successors, as they may be amended from time to time."

(3) The above amendments to the corporation's Articles of Incorporation were made by resolution adopted by unanimous consent of a quorum of Trustees (Directors) of Fellowship For International Revival And Evangelism, Inc. at a special meeting held on January 26, 2000, there being no members having voting rights in respect thereof.

(4) These Articles of Amendment shall be effective upon their filing with the Division of Corporations.
