**ARTICLES OF INCORPORATION
OF
ASWA, INC.
(a Florida non-profit corporation)**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I – Name

The Name of the corporation shall be: ASWA, Inc.

Article II – Principal Office

Article III – Purpose

The specific and primary purposes for which this corporation is formed are to engage generally in the work of safeguarding the rights of the members to promote the soil conservation, water control and reclaimed water industry to the general public, to educate its members concerning liability insurance risks, to represent its members as a whole to various state, federal or other regulatory agencies, to arrange for liability insurance placement for its members and to sponsor a master insurance policy for the association for the members with licensed and qualified persons or companies.

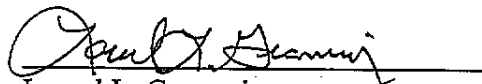
