## ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporation of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

### FIRST

The name of the corporation is: Central Florida Kids II Corporation, desiring to form a non profit corporation, under the non profit corporation law of Florida

### SECOND

The period of its duration is: Indefinitely

### THIRD

The purpose of the corporation is: Organized exclusively for charitable, educational purposes, that qualify as exempt organization under IRS CODE 501 C.3 or corresponding section of any future tax code for the purpose of a non profit child care center.

### FOURTH

Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: upon dissolution of the corporation assets, shall be distributed for one or more exempt purposes under 501 3 C of the IRS Tax Code under approval of the board of directors.

### FIFTH

Provisions for regulating the internal affairs of the corporation are: No Part of the net earnings of the corporation shall insure to the benefit of or be distribiable to it members, trustee officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, notwithstanding any provision of these articles the corporation shall not carry on any other activity not permitted by a corporation exempt from federal income tax under section 501 3 C of the internal revenue service or this corporation shall not engage in any activities or exercise any powers that are not in furtherance to the proposes of this corporation,

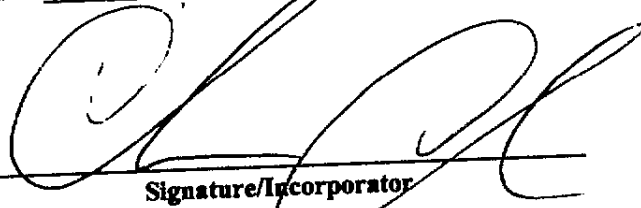

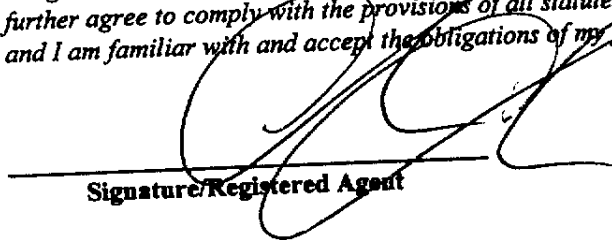
