The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation

#### ARTICLE I

#### NAME

The name of this corporation shall be: Rainbow Ministries Church Of God In Christ, Inc.

#### ARTICLE III

# Purpose

The purpose for which the corporation is organized are:

#### ARTICLE IV

## Manner of election of Officers

As soon as the proposed alterations or amendments shall have been adopted as herein provided, the result of the vote shall be announced by the Secretary and declared adopted by the Pastor, and filed with the Secretary of the State of Florida, where upon such alterations or amendments shall be full force and effect.
