Pursuant to Florida Statutes §617.1403, the undersigned corporation adopts these Articles of Dissolution:

The name of the corporation is Partners for Environmental & Economic Progress, 1. Inc. ("Corporation").

The Corporation was formed on November 9, 1999 under document number 2. N9900006638.

3. The Corporation has no net assets.

The procedure for dissolving the Corporation in accordance with the Articles of 4. Incorporation is to obtain the affirmative vote of two thirds of the Membership and two-thirds of the Board of Directors.

5. The Board has three (3) directors in office as of the date of these Articles of Dissolution. 8. Any net assets of the corporation later discovered shall be distributed by the directors to one or more 501(c)(3) organizations in accordance with the Plan of Dissolution of the Corporation.
