**NORTH-SIDE AFFORDABLE HOUSING OPPORTUNITIES, INC.**

The undersigned associate together for the purpose of becoming a corporation not for profit under Chapter 617, laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

**ARTICLE I: NAME**

The name of this not for profit corporation shall be **NORTH-SIDE AFFORDABLE HOUSING OPPORTUNITIES, INC.**

**ARTICLE II: PURPOSE**

This not for profit corporation is organized exclusively for religious, charitable, scientific, literary and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the successor provision of any future United States Internal Revenue law. The mission of this corporation is to provide affordable housing for sale or rental to qualified applicants. To achieve this mission, the corporation may purchase or receive as gifts real property. To the end that the foregoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, this corporation shall have the power to engage only in such activities as shall not constitute business unrelated to its religious, benevolent, charitable, literary and educational purposes. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the successor provision of any future United States Internal Revenue law. Subject to the foregoing limitations, this corporation shall have all of the rights and powers set forth in section 617.0302, Florida Statutes.

**ARTICLE III: PRINCIPAL OFFICE**

The street address of the initial principal office is 4000-B, St. Johns Ave., Suite 24, Jacksonville, Florida 32205. The mailing address of **NORTH-SIDE AFFORDABLE HOUSING OPPORTUNITIES, INC.** is the same as the street address for the initial principal office.

#### ARTICLE IV: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 603 North Market Street, Jacksonville, Florida 32202, and the name of the initial registered agent of this corporation at the address is Charlie J. Gillette, Jr., Esq.

#### ARTICLE V: DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are filed.
