ARTICLES OF INCORPORATION
OF
ST. MARY'S PARISH OF THE ST. JOHN'S ORTHODOX CATHOLIC CHURCH, INC.
A non profit corporation

ARTICLE 1 - NAME

The corporation shall be St. Mary's Parish of the St. John's Orthodox Catholic Church, Inc.

ARTICLE 2 - DURATION OF THE CORPORATION

The duration of this corporation shall be perpetual and shall have continued existence under this Certificate from the date of issuance thereof.

ARTICLE 3 - PURPOSE

The general purpose of this Corporation is to take charge of and manage all the temporal affairs of the St. Mary's Parish of the St. John's Orthodox Catholic Church, in said parish; to promote the spiritual, educational, and other interests of said St. Mary's Parish of the St. John's Orthodox Catholic Church, Inc., in said parish, including all the charitable, benevolent, and eleemosynary work of said church in said parish; to take charge of, hold and manage all property, personal and real that may at any time or in any manner come to or vest in this Corporation for any purpose whatever, whether by purchase, gift, grant, devise or otherwise, and do all other acts required subject to and in accordance with the Constitution and law, decrees and directives of Synods and the duly elected and appointed authorities of the St. Mary's Parish of the St. John's Orthodox Catholic Church.

ARTICLE 4 - CONGREGATION

This parish shall under the jurisdiction of it's parishoners' and Bishop, and their lawfully elected or appointed authorities, shall conduct itself as a congregational church.

ARTICLE 5 - MEMBERSHIP

The membership of this Corporation shall consist of all those persons who desire to maintain membership in and abide by the rules and requirements of the St. Mary's Parish of the St. John's Orthodox Catholic Church as expressed by its Constitution and laws and the By Laws, Rules and Regulations of this parish.

ARTICLE 6 - DIRECTORS

In matters of material, economic and social nature the members of this parish shall the control and management thereof subject to the provisions of the Constitution and laws of the St. Mary's Parish of the St. John's Orthodox Catholic Church, by and through a board of directors consisting of not less than three (3) persons all of whom shall be members in good standing of this parish and who shall be selected in accordance with the By Laws of the parish.

ARTICLE 7 - INCORPORATORS

The initial directors shall be the incorporators. The incorporators names and addresses are as follows:

1. Nina Przepierzynski - President - 3632 Benson Avenue North
St. Petersburg, FL 33713
2. Valentin Ianev - Vice-President
3. Rebekah Arsenault - Secretary
4. Grazyna Gorska - Treasurer

ARTICLE 8 - OFFICERS OF THE PARISH

The initial officers of the parish shall be:

1. The Pastor shall be selected in accordance with the Constitution and laws of the St. John's Orthodox Catholic Church.
2. Chairman of the Board of Directors.

3. Vice-Chairman of the Board of Directors.
4. Recording Secretary of the Board of Directors.
5. Financial Secretary of the Board of Directors.
6. Treasurer.

All of the foregoing offices except the Pastor shall be elected annually in accordance with the terms and provisions of the By Laws of the Corporation.

ARTICLE 9 - BY LAWS

By Laws of the Corporation shall be made, altered or rescinded by a majority vote of the membership, provided however that only those members holding membership at least one year in said Parish shall be eligible to vote on any such change.

ARTICLE 10 - AMENDMENTS

This charter may be amended by the membership of the parish by a affirmative vote of two-thirds (2/3) of the members.

ARTICLE 11 - INITIAL REGISTERED OFFICE AND AGENT
