Article XII is deleted in its entirety and the following new Article XII is inserted in its place:

## **ARTICLE XII – DISSOLUTION**

"Upon dissolution of the Church, all of the assets of the Church (after the payment of all debts and other obligations) shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose".
