We, THE UNDERSIGNED, acting as Incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation.

ARTICLE I - NAME

The name of the corporation shall be:

CHISPA UNITED METHODIST MISSION, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III - PERIOD OF DURATION

The period of duration of this corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE IV - PURPOSES

The more specific purposes for which the corporation is organized are:

The purposes for which the organization is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. This corporation is organized not for profit and for the following purposes:

The objects and purposes of the corporation are the preaching of the gospel; the teaching of the Bible; the maintenance of Christian missions; the relief of suffering; the extension of the Christian education, and such other activities and services as could properly come within the province of an institution of religion; the support of the doctrines, laws, usages and ministerial appointments of the Methodist Church as are from time to time established, made and decided by the lawful authority of the Methodist Church; to secure, hold, improve, encumber, sell, convey and dispose of property both real and personal, in fee simple, or otherwise as provided for in the

Book of Discipline of the United Methodist Church; to establish and administer a revolving fund for education purposes, to establish Christian education on its present location, or on other locations if opportunity or need arises in the judgment of the Board of Directors; to use all income from whatever sources, including profits on sales of real estate; interest, dividends or donations exclusively for the enlargement or operation of the corporation's facilities; the advancement of education, the spreading of the Gospel and the carrying forward of such humanitarian activities as would come within the scope of organized religion; to accept and establish memorials and to do all other things incident to church and religious activities and services as properly come within the province of an institution of religion.

ARTICLE V - QUALIFICATION FOR MEMBERS

The qualifications for members and the manner of their admission are according to the rules and regulations set forth in the Discipline of the Methodist Church.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The number constituting the initial Board of Directors of the Corporation are five (5) and the names and addresses of the persons who are to serve initially are:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 5012(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

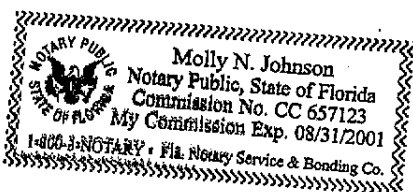
