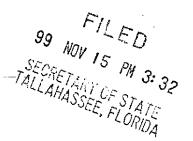

I, the undersigned resident of the State of Florida, being eighteen (18) or more years of age, do hereby associate myself for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation is MERRITT ISLAND BABE RUTH SENIOR LEAGUE, INC.

ARTICLE II

Principal Office

The street address of the principal office of the corporation is 180 E. Merritt Avenue, Merritt Island, Florida 32953 and the mailing address of the corporation is Post Office Box 541017, Merritt Island, Florida 32954-1017.

ARTICLE III

Registered Agent

ARTICLE IV

Duration

The period of duration of this corporation not for profit shall be perpetual.

ARTICLE V

General and Specific Purposes

The specific and primary purposes for which this corporation is formed is to provide, education, training, and coaching, in a positive and structured environment for youths to develop baseball and teamwork skills.

ARTICLE VI

Member Corporation

This corporation shall be a member corporation.

ARTICLE VII

Non-Stock Corporation

This corporation shall be non-stock and no-dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE VIII

ARTICLE IX

Directors

The number of directors constituting the initial board of directors is three (3) and the names and addresses of the persons who are to serve initially are as follows:

The number of directors may be changed from time to time by the By-laws, provided the number of directors is not reduced below three (3) directors. The By-laws shall set forth the method of election of directors.

ARTICLE X

By-laws

The By-laws of this corporation shall be approved by a majority vote of the Board of Directors. The By-laws may be amended or rescinded in the same manner.

ARTICLE XI

Amendment to Articles

The Articles of Incorporation may be amended by a majority vote of the Board of Directors.

ARTICLE XI

Dissolution

Upon dissolution of this organization, all assets shall be distributed, for one or more exempt purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
