Articles Of Incorporation
Of
TREASURE COAST MULTI SERVICES, INC.

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statute adopts the following Article of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be **Treasure Coast Multi Services, Inc.**

ARTICLE II - PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the business of providing outpatient mental health services to indigent patients.

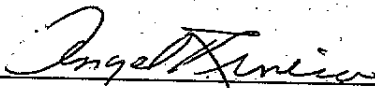

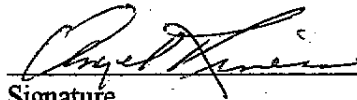
