ARTICLES OF INCORPORATION

OF

YOUTH, BRING A FRIEND, INC.

EFFECTIVE DATE

11-9-99

ARTICLE I - NAME

The name of this corporation is Youth, Bring a Friend, Inc.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing on November 9, 1999.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of an after school tutoring and youth interaction program for youth as allowed under Section 501 subsection to C (3) of the Internal Revenue Code.

No part of the net earnings of the Corporation shall inure the benefit or be distributable to its members, trustees, directors, officers or other private persons except that Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of Section 501 C (3) purposes. No substantial part of the activities of the Corporation shall be carrying on of propaganda or otherwise attempting to influence legislation, and Corporation shall not display participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of, or opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not be permitted to be carried on (a) by corporation exam from Federal income tax under Section 501 C (3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by corporation, contributions to which are deductible under section 170 C (2) of the Internal Revenues Code (or corresponding section of any future Federal Tax Code).

Upon the dissolution this corporation asset shall be distributed for one or more exempt purposes within the meaning of Section 501 C (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government for public purpose.

This corporation is a Florida not-for-profit corporation organized to comply with the terms and conditions of 26 U.S.C. Section 501 as a not-for-profit corporation and compile all terms, rules and obligations thereof.
