In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a corporation not for profit.

ARTICLE I - NAME

The name of the corporation shall be: DYING TO LIVE AGAIN FOUNDATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The street address of the initial principal office of this corporation is 101 N. Riverside Drive #113, Pompano Beach, FL 33062, and the mailing address of the corporation is the same.

ARTICLE III - PURPOSE

This corporation is being organized not for pecuniary profit and for the purpose of educating people to the reality of death so as to prepare them and their families for this inevitable occurrence to allow them to accept death with comfort and dignity.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

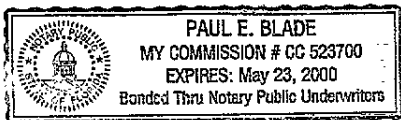
